### Łódź Bar of Attorneys-at-Law

Łódź Bar of Attorneys-at-Law (OIRP in Łódź) is a professional bar of attorneys-at law. OIRP in Łódź unites approximately two thousand two hundred of attorneys-at-law from Łódź region, which membership is mandatory according to the law. The OIRP in Łódź supervises the proper performance of the profession by its members, conducts disciplinary proceedings in case of violation of professional ethics, and also organizes training of trainees and lifelong continuing legal education for attorneys-at-law. The aim of the activities of attorneys-at-law is to provide legal services and representing clients before courts and tribunal of all instances as well as before public bodies and administrative courts. While performing his or her profession, an attorney-at law is granted with the full independence. Fundamental values of professional ethics like professional secrecy, avoidance of conflict of interests are also protected. All attorneys-at law must have professional indemnity insurance. The Łódź Bar of Attorneys-at-law actively co-operates with international organizations and lawyers' association in organizing conferences, seminars and training.
