## The conference

### Purpose

The European Association of Lawyers (AEA-EAL) has received several information from its members on growing issues regarding posting of workers in the European Union. On one side sending countries were on the opinion that any further limitation of temporary work in another member states, according to Directive 96/71/EC of the European Parliament and of the Council of 16 December 1996 concerning the posting of workers in the framework of the provision of services will be contrary to the freedom of services and may limit the economic benefits for the EU as a whole. On the other side receiving countries underlined the need of protection their internal markets and social welfare of employees. This year a major step of changes in the EU system of posting workers has been made by adopting a new Directive (EU) 2018/957 of the European Parliament and of the Council of 28 June 2018 amending Directive 96/71/EC concerning the posting of workers in the framework of the provision of services. Taking into account different views and opinions as well as ongoing legislative process, the AEA-EAL has decided to organize a conference in Lyon (France) in the premises of the Lyon Bar to gather interested parties and to discuss the issue.

### **Program and speakers**

The main goal for the organizers was to bring together stakeholders: representatives of member States, EU institutions, sending and receiving companies, organizations of employers and employees as well as lawyers dealing with this issue. Program of the conference was set up to show the participants policy and legal environment of the existing system, changes introduced this year by the EU as well as ongoing deliberations and specificity of certain sectors like transport. The whole seminar was finished with the presentation of the EU jurisprudence and summary of conference debates.

#### Results

We gathered top-level speakers and experts from seven EU countries including high representatives of the French government, judge of the EU Court of Justice, prominent lawyers, entrepreneurs, representatives of trade unions and unions of industry and service's sectors. The participants coming from eight EU Member States actively participated in a very live discussions and question sessions. High interests expressed during the conference should result in organizing similar events in the future. Participants received CPD credits in the framework of continuing legal education.
