Belt and Road Initiative

- Launched by the Chinese government in 2013
- To promote economic co-operation among countries and regions along the Belt and Road routes
- Involves over 65 countries - jointly account for:
 - around 62% of the world's population
 - around 30% of the world's GDP
- Arrangement between the National Development and Reform Commission and HKSAR Government for Advancing Hong Kong's Full Participation in and Contribution to the Belt and Road Initiative (signed in December 2017)

Latest Development of the Belt and Road Initiative

- Under the theme “Belt and Road Cooperation, Shaping a Brighter Shared Future”, the second Belt and Road Forum for International Cooperation was held in Beijing on 25-27 April 2019 to promote the development of the initiative.
- On 5 March 2019, Premier Li Keqiang said in his annual work report that the Central Government would support Hong Kong and Macao in seizing the vast opportunities brought by the Belt and Road Initiative and the Greater Bay Area development, capitalising on their respective advantages, and deepening their mutually beneficial cooperation with the Mainland.
- According to the Ministry of Commerce, China’s foreign direct investment (“FDI”) rose by 4.2% to USD 129.8 billion in 2018. Meanwhile, Hong Kong was the largest offshore RMB clearing centre in 2018, processing about 79% of the world’s RMB payments.



- Founding member of WTO
- Member of Asia-Pacific Economic Co-operation (APEC), Asian Development Bank (ADB) and Asia Infrastructure Investment Bank (AIIB)
- A popular venue for hosting regional headquarters or representative offices
- 17 Economic and Trade Offices set up by the HKSAR Government
- 8 Free Trade Agreements (“FTA”) with China, New Zealand, European Free Trade Association, Chile, Macao, ASEAN, Georgia and Australia

Strategic Geographic Location

- Point-to-point air transportation:
 - Asia's key markets within 4 hours
 - Half of the world's population in 5 hours
 - 120 airlines to 220 locations worldwide
 - Onward connections for sea and land transportation
 - high-frequency air cargo services connected to all regions in the world
- Three-runway system
- Guangzhou-Shenzhen-Hong Kong Express Rail Link and Hong Kong-Zhuhai-Macao Bridge

World's Freest Economy

- Hong Kong Government policy of “market driven with minimal government interference”
- Free trade & free enterprise – no tariffs, no quotas, no exceptions, no nationality restrictions on corporate or sectoral ownership
- Strong emphasis on rule of law and fair market
- Free import and export of capital funds
- Free repatriation of funds – no restrictions on capital flows into and out of Hong Kong
- No foreign currency regulations
- Ranked first in terms of economic freedom for 25 years according to the Heritage Foundation
- Ranked No.4 globally on the ease of doing business according to the World Bank Group's Doing Business 2019 Report

Belt and Road Committee (“BRC”)

- Established in December 2015 to explore opportunities for members arising from the Initiative.
- The scope of work included:
 - a) to update the Committee on government policy on the Initiative;
 - b) to reach out to overseas lawyers associations covered by the Initiative;
 - c) to consider possible initiatives to harmonise trade and business law; and
 - d) to organise joint conferences or events with overseas lawyers associations.

1st Belt and Road Conference (May 2017)

- Theme: “The Belt and Road: A Catalyst for Connectivity, Convergence and Collaboration”
- Attended by around 600 delegates from jurisdictions along the Belt and Road
- 39 lawyers’ associations from 24 jurisdictions signed the “**Hong Kong Manifesto**”, pledging to promote synergy, strategic partnership and collaboration amongst the signing members



2nd Belt and Road Conference (September 2018)

- Theme: “The ABC to Building a Smart Belt and Road: Law and Artificial Intelligence, Blockchain and Cloud”
- Attended by over 650 delegates from jurisdictions along the Belt and Road
- 34 lawyers’ associations from 17 jurisdictions signed the “**LawTech Alliance**”, which all have the common goal of ensuring that the profession will take advantage of legal tech in an ethical, professional and responsible manner, and promoting a shared ethical Artificial Intelligence (“A.I.”) framework for lawyers from the Belt and Road regions.



 - Almost 150 individuals in 30 teams signed up
 - The first Hackathon focusing on access to justice challenges in the Belt and Road Region
- The Hackathons are part of the Law Society's initiative to enhance technology competency in the law and promote legal innovation
- Show that there is a great interest in developing a technology-focused community for promoting access to justice in Hong Kong and the Belt and Road Region
